

**ARTICLES OF INCORPORATION**

**ARTICLE I – NAME**

The name of the corporation shall be Grand Slam Cellular, Inc.

**ARTICLE II – PRINCIPAL OFFICE**

The principal place of business/mailling address is 2804 E. Irlo Bronson Highway,  
Kissimmee, Florida 34744.

**ARTICLE III – PURPOSE**

The purpose for which the corporation is organized is for transacting in any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

**ARTICLE IV – SHARES**

**A. One Class of Stock**

The corporation is authorized to issue all of its shares under one (1) class of common stock only with no authorization to issue shares of another class. No other class of stock, other than common stock, shall be created through preferences, special rights, qualifications, limitations, or restrictions of any kind.

**B. Capitalization**

The capital stock of this corporation shall be ten thousand dollars (\$10,000) and shall be divided into one million (1,000,000) shares of one hundredth of a dollar (\$0.01) par value each, and shall be fully paid before the corporation begins the transaction of its business.

**C. Restrictions on Transferability**

All of the issued and outstanding shares of the corporation shall be made subject to restrictions on their transferability by agreement between the holders of such shares and the corporation. A copy of such agreement shall be kept on file with the secretary of the corporation; and shall be subject to inspection by shareholders of record and bona fide creditors of the corporation at reasonable times during business hours.


