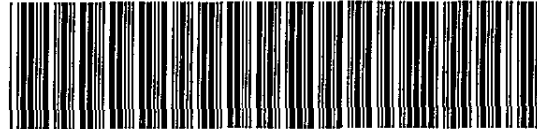

**AMENDMENT**




