The name of the registered agent of the corporation is Norman Dupont. The address of this registered agent is 958 NW 73rd Street, Miami, Florida, 33150.

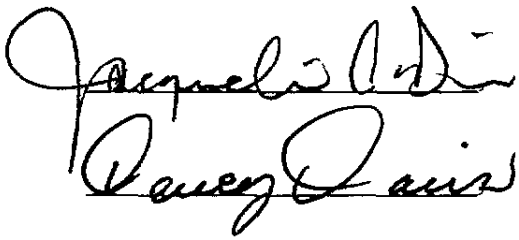
ARTICLE VIII – BYLAWS

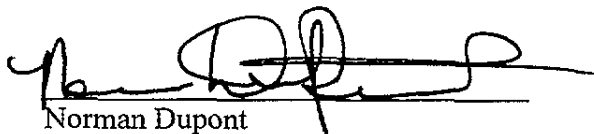
