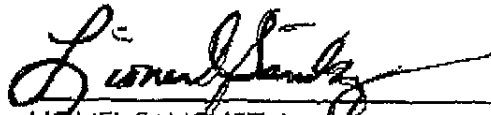
**ARTICLE X

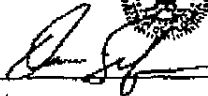
