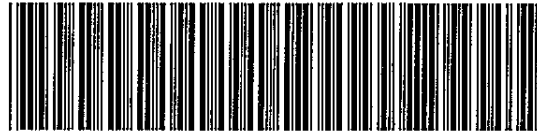

ARTICLE ONE

The name of the corporation is PALM TREE WOODWORKING, INC.

ARTICLE TWO

The period of its duration is perpetual.
