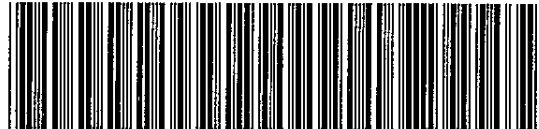

ARTICLES OF INCORPORATION
OF
MERE-CHEL LEASING COMPANY

ARTICLE I – Name and Address
