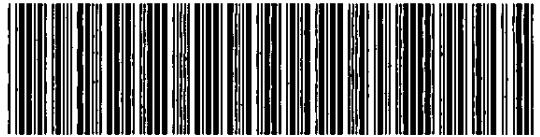

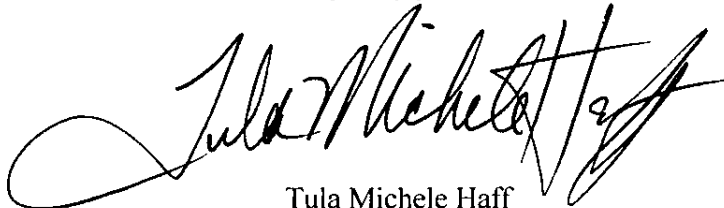

FIRST: The name of the corporation is GARRETT'S CERTIFIED WELDING, INC.

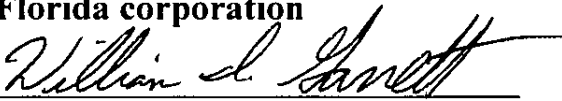
SECOND: Dissolution was authorized on 08/15/08 and shall be effective as of 08/15/08.
