ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SKYETEC ENVIRONMENTAL DIAGNOSTIC SERVICES, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST:

The name of the Corporation is SkyeTec Environmental Diagnostic Services, Inc.

SECOND: Article ItI of the Articles of Incorporation of Skyetec Environmental Diagnostic Services, Inc. is hereby amended in its entirety to read as follows:

ARTICLE III Stock

The total authorized capital stock for the Corporation shall consist of 100,000 shares of Common Stock, par value \$.01 per share and 10,000 shares of Series A Preferred Stock having the following rights and preferences. The Series A Preferred Stock shall be senior to the Common Stock and shall have a preference to all distributions, whether through distribution or upon liquidation, in the amount of \$100,000,000, in the aggregate as a class. All distributions of the Corporation shall be made ratably, first to the Series A Preferred Stockholders, until such time as the Series A Preferred Stockholders have received, in the aggregate, \$100,000,000. Thereafter, the Series A Preferred stockholders shall not be entitled to any further distributions and all residual distributions shall be made ratably and exclusively to the common stockholders. The Series A Preferred Stockholders shall have no voting rights, except as otherwise expressly provided by law.

THIRD:

The date of this amendment's adoption is June \mathcal{G}_{-} , 2009.

FOURTH: This amendment was adopted by the Board of Directors and Shareholder of this Corporation. The number of votes cast by the shareholders was sufficient for approval.
