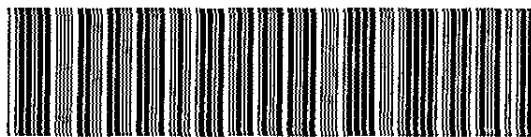

**ARTICLES OF INCORPORATION  
OF  
CONTINENTAL INDUSTRIAL RESOURCE CORPORATION**

**ARTICLE I -- NAME**

The name of this corporation is and shall be – **CONTINENTAL  
INDUSTRIAL RESOURCE CORPORATION.**

**ARTICLE II – DURATION**

This corporation shall exist in perpetuity.

**ARTICLE III – PURPOSE**

This corporation is organized for to conduct and carry on the  
business of Industrial, Oil field, agricultural, merchants and trade in all  
lawful businesses, both domestic and foreign.

**ARTICLE IV – CAPITAL STOCK**

This corporation is authorized to issue 255,000 shares of Preferred  
Voting Stock, and 345,000 shares of Common Non-Voting Stock, each  
having a par value of one cent, (\$0.01), for a total of 600,000 shares.

#### **ARTICLE V – PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock of this corporation, (of the same kind, class or series as that which he/she already holds), shall have the right to purchase her/his pro rata share thereof, (as nearly as may be done without issuance of fractional shares thereof), at the price at which it is offered to others. The exercise of the sales has to be authorized by the majority of the directors.

#### **ARTICLE VI – TRANSFER OF SHARES**

Any shares of a deceased member may be transferred by his executor or administrator to the widow or widower, child or grandchild of such deceased member and Regulation of the State of Florida shall be modified accordingly.




