The undersigned incorporator hereby forms a corporation under Chapter 609 of the Laws of the State of Florida.

ARTICLE I NAME

The name of the corporation shall be:

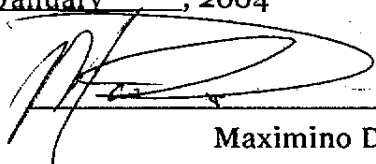
