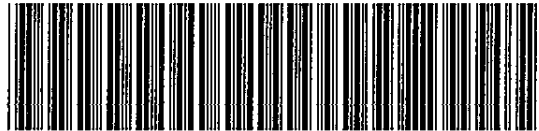

The undersigned incorporator hereby forms a corporation under Chapter 607, Part I, of the Laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation shall be Ruckus, Inc. (the "Corporation"). The address of the principal office of the Corporation shall be 14320 Bruce B. Downs Boulevard, Tampa, Florida 33613 in Hillsborough County, and the mailing address shall be the same.

ARTICLE II. CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is one hundred thousand (100,000) shares of common stock having a par value of \$0.01 per share.

ARTICLE III. INITIAL REGISTERED AGENT AND STREET ADDRESS

The street address of the initial registered office of the Corporation shall be 401 East Jackson Street, Suite 2500, Tampa, Florida 33602, and the name of the initial registered agent of the Corporation at that address is R. Andrew Rock, Esquire.

ARTICLE IV. INCORPORATOR

ARTICLE V. NUMBER OF DIRECTORS

The business of the Corporation shall be managed by a Board of Directors consisting of not fewer than one (1) Director with the exact number to be determined from time to time in accordance with the Bylaws of the Corporation. The Board of Directors shall have two (2) Directors initially.

The names and street addresses of each initial Director of the Corporation, who shall hold office until the first annual meeting of shareholders, and thereafter until his successor is elected, are as follows:



These Articles of Incorporation may be amended, modified, repealed, restated, or replaced only as set forth in the Bylaws of the Corporation.


