

ARTICLES OF INCORPORATION

OF

SATELLITE BEACH INC.



ARTICLE I - NAME

The name of this Corporation is SATELLITE BEACH INC. (hereinafter referred to as the "Corporation")

ARTICLE II - DURATION

This Corporation shall exist perpetually, commencing upon the filing of the Articles of Corporation by the Department of State.
