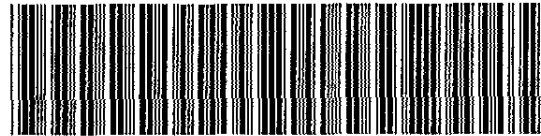

ARTICLE I




