Daulton W. Kirkland	10 shares

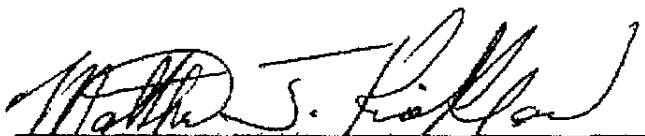

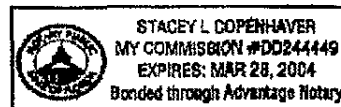

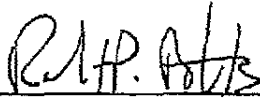
