# ARTICLES OF INCORPORATION OF:

M. T. & N., CORP. 551 East 39th Street Hialeah Florida 33013

#### ARTICLE I - NAME

The name of this corporation is: M. T. & N., CORP.

# ARTÍCLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.

#### ARTICLE III - PURPOSE
