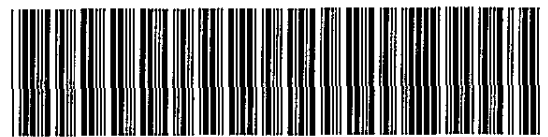

**Off The Dime, Inc.
Articles of Incorporation**

This entity is formed under the *Florida Business Corporation Act*, Chapter 607 of the *Florida Statutes* by the filing of these articles of incorporation with the Department of State.

1. **Name.** The name for this corporation is *Off The Dime, Inc., a Florida business corporation.*
2. **Initial Principal Office.** The street address of the initial principal office is 4 St. George Street, St. Augustine, Florida 32084. That street address is the mailing address of this corporation.
3. **Authorized Shares.** This corporation is authorized to issue 100 shares of common voting stock. This stock will have a par value of \$1 per share.
4. **Preemptive Rights.** This corporation elects to have preemptive rights as provided in Section 607.0630 of the Act.
5. **Initial Registered Office and Initial Registered Agent.** The street address of this corporation's initial registered office is 4 St. George Street, St. Augustine, Florida 32084. The name of its initial registered agent at that office is Irving Kass. The initial registered agent has signed at the end of these articles to make his statement of acceptance as required by *Florida Statutes* Section 607.0501(3).
6. **Incorporator.** The name and address of the incorporator is Irving Kass at 4 St. George Street, St. Augustine, Florida 32084.
7. **Oral Notice.** Oral notice to shareholders, to directors, and to officers is authorized if it is reasonable under the circumstances.
8. **Shares Without Certificates.** The board of directors may authorize the issuing of some or all of the shares without certificates as permitted by Section 607.0626 of the Act.
9. **Effective Date.** The effective date of these articles is the date upon which they are accepted by the Department of State.

These articles of incorporation are being signed by the incorporator on this
