Off The Dime, Inc. First Amendment of Articles of Incorporation

This entity was formed under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes by the filing of the articles of incorporation with the Department of State on January 28, 2004, Document Number P04000021521. These articles are the first amendment to those articles of incorporation made pursuant to Section 607.1006.

- 1. Name. The name for this corporation is Off The Dime, Inc., a Florida business corporation.
- 2. Amendment: Authorized Shares. This corporation was authorized to issue 100 shares of common voting stock with a par value of \$1 per share. This corporation is in need of issuing additional shares of common stock without a stated par value. Therefore, this corporation is authorized to issue an additional 100 shares of common voting stock, for a total authorization of 200 shares.
- 3. **Effective Date.** The effective date of these articles of amendment is the date of their acceptance by the Department of State.
- 4. Adoption. The original authorization of 100 shares was employed at the organizational meeting on January 28, 2004 for the issuance of all 100 shares as follows: 50 shares to Irving J. Kass and Susan A. Kass, husband and wife, as an estate by the entireties; and 50 shares to Barbara Conathan. All of those shareholders cast all of their shares in favor of these articles of amendment, and each of them has signed these articles.
