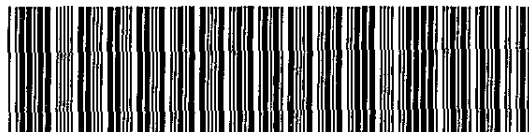

The undersigned Incorporator named herein does hereby subscribe to and file these Articles of Incorporation for the purposes of organizing a corporation under the Florida Business Corporation Act.

**ARTICLE I - NAME**

The name of the corporation is **NICOLE HALL, P.A.**

**ARTICLE II - BUSINESS ADDRESS**

The address of the corporation is 4325 W. Sunrise Blvd., Plantation, FL 33313.

**ARTICLE III - DURATION**

The corporation shall exist perpetually. The corporate existence shall commence as of the filing of the Articles of Incorporation.

**ARTICLE IV - PURPOSE**

The purpose of this Corporation is to provide Real Estate Services. And in connection therewith and in furtherance thereof, to possess and exercise all the powers and privileges granted by the Florida Business Corporation Act or by any other law of Florida or by these Articles of Incorporation together with any powers incidental thereto, so far as such powers and privileges are consistent with, and not prohibited by, the Professional Service Corporation and Limited Liability Act.

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.

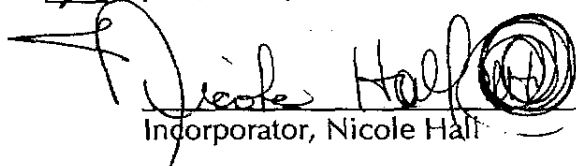
**ARTICLE X

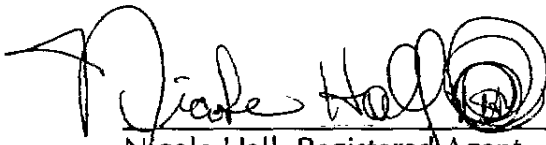
