ARTICLES OF INCORPORATION
OF
CARL GOODWIN INSTALLATIONS, INC.

The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is Carl Goodwin Installations, Inc.

ARTICLE TWO

PRINCIPAL OFFICE AND ADDRESS

The address of the principal office of the Corporation is 2406 Diehl Road, Tallahassee, Florida 32308, and the mailing address of the Corporation is 2406 Diehl Road, Tallahassee, Florida 32308.

ARTICLE THREE

SHARES, CLASS AND PAR VALUE

The Corporation is authorized to issue one class of shares, which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon dissolution. The Corporation is authorized to issue 1,000 common shares, and shall have a par value of \$1.00 each.

The registered agent, Carl E. Goodwin hereby accepts appointment as registered agent for the Corporation, Carl Goodwin Installations, Inc.


ARTICLE SIX


