

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: JNQ Transport, Inc.

The address of the principal office of this corporation shall be 6304 N. Ocean Boulevard, Boynton Beach, Florida 33435, and the mailing address of the corporation shall be the same.

ARTICLE II - NATURE OF BUSINESS


