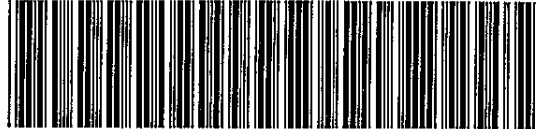

ARTICLE I: NAME: The name of this corporation shall be *United Cleaners of Central Florida, Inc.*
