Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of this Corporation is C. J. WAHRMAN III, P.A. (the "Corporation").
2. The general nature of the professional services to be rendered by the Corporation shall be to engage in the practice of rendering legal services. The Corporation may not engage in any business other than the practice of rendering legal services. However, the Corporation may invest its funds in real estate, mortgages, stocks, bonds and other types of investments and may own real and personal property necessary for the rendering of the professional services authorized hereby.
3. The street address of the initial principal office of the Corporation is 235 NW 48<sup>th</sup> Avenue, Deerfield Beach, FL 33442; the mailing address of the initial principal office of the Corporation is the same.
4. The aggregate number of shares which the Corporation is authorized to issue is 100,000 shares of Common Stock, par value \$.01 per share.
