The undersigned, for the purpose of creating a corporation under the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

CORPORATE NAME AND PRINCIPAL OFFICE

The name of the corporation is DL SIMS CONSTRUCTION, INC., and its principal office is 173 Marcia Drive, Mary Esther, FL 32569.

ARTICLE TWO

NATURE OF BUSINESS
