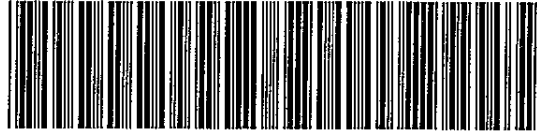

PRE-EMPTIVE RIGHTS


