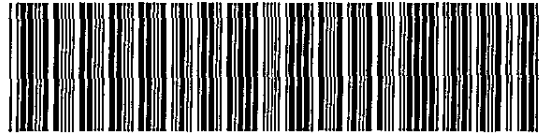

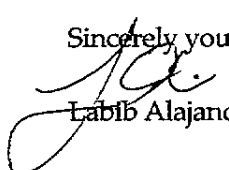

The undersigned Incorporator, a natural person competent to contract, hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

**ARTICLE I**  
**Name**

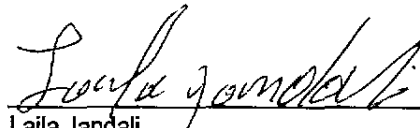
**ARTICLE XI**

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

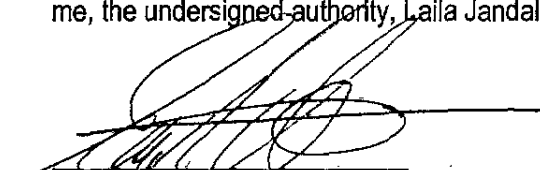

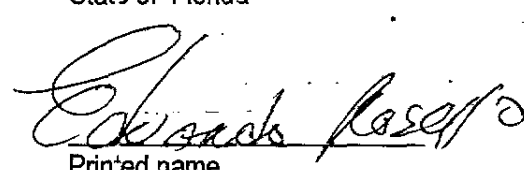
