The undersigned, acting as incorporator of a corporation under the Florida General

Corporation Act, adopted the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME

The name of the corporation is, SHABBA SHOES AND THINGS, INC.

ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

ARTICLE III - NATURE OF BUSINESS

This corporation is organized for the purpose of sale of Shoes, Accessory and Handbags and Doing business as permitted under the laws of the United States and the State of Florida.

ARTICLE IV - AUTHORIZED SHARES
