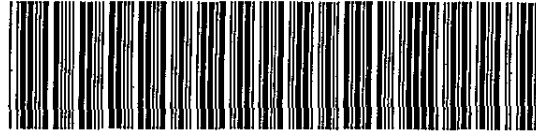

ARTICLES OF INCORPORATION
OF
WGASA, INC.

The undersigned natural person, acting hereby as Incorporator for the purpose of forming a Corporation for profit under the provisions of Chapter 607, Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

I

NAME OF CORPORATION, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of this Corporation shall be WGASA, INC.; the principal office of this Corporation shall be 1436 Stonehaven Estates Drive, West Palm Beach, Florida 33411, and the mailing address of this Corporation shall be the same.

II

PURPOSES

The general nature and purposes of business to be transacted, promoted and carried on by the corporation is any lawful business activity permitted under the Laws of the State of Florida or elsewhere.

III

CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be Ten Thousand (10,000) shares of common stock at One (\$1.00) Dollar per share par value.

IV

DURATION

The corporation shall have perpetual existence.

V

REGISTERED AGENT

The address of this corporation's initial registered office is 1400 Centrepark Blvd., Suite 860, West Palm Beach, Florida 33401, and the name of its initial registered agent at said address is John M. Severson, Esquire.

VI

INCORPORATOR

VII

BOARD OF DIRECTORS

The corporation shall have a Board of Directors consisting of one person. The number of Directors may be increased or decreased from time to time by a resolution of the majority of the Stockholders but shall never be less than one. The Incorporator shall be the initial director of the Corporation and her name is set forth in Article VI above.

VIII

BYLAW AMENDMENT

The power to adopt, alter, amend or repeal the bylaws of this corporation shall be vested in the Board of Directors and Stockholders.
