The undersigned subscriber to these Articles of Incorporation, a natural person Competent OF STATE TALLAHASSEE. FLORIDA to contract, for the purpose of forming a corporation under The Florida General Corporation Act,

Florida Statutes Chapter 607, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

This corporation shall be known as RED'S TRENCHING, INC.
