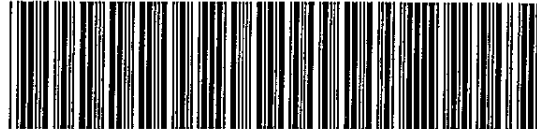

ARTICLES OF INCORPORATION

OF

Jim Adams Interiors INC..

ARTICLE I. CORPORATE NAME

This Corporation is to be a Professional Service Corporation formed under Florida Statutes Chapter 621, the Professional Service Corporation and Limited Liability Company Act of the State of Florida and is to be known as Jim Adams Interiors INC.

ARTICLE II. PRINCIPAL OFFICE

The physical address of the principal office of the Professional Service Corporation to be known as Jim Adams Interiors INC 4009 Watson RD, Tampa FL. 33610 and the mailing address of the Professional Service Corporation to be known as Jim Adams Interiors INC. 4009 Watson RD, Tampa FL> 33610.

ARTICLE III. NATURE OF BUSINESS AND POWERS

The Professional Service Corporation to be known as Jlm Adams Interiors INC. is a Professional Service Corporation formed under Florida Statutes Chapter 621, the Professional Service Corporation and Limited Liability Company Act of the State of Florida. The general nature of the business to be transacted by the Professional Service Corporation to be known as Jim Adams Interiors INC. is and shall be to engage in every aspect of the Interior Decorating or wallpapering. The professional services involved in the corporations's practice is wallpapering .

This corporation may invest its funds in real estate, mortgages, stocks, bonds, and any other types of investments and may own real and personal property necessary for the rendering for the professional services authorized hereby.

ARTICLE IV. CAPITAL STOCK

The Professional Service Corporation to be known as Jim Adams Interiors INC. is being organized with the intent of maintaining eligibility to be treated as an S corporation under the rules of Subchapter S of the Internal Revenue Code. The maximum number of shares of stock that the Professional Services Corporation to be known as Jim Adams Interiors INC. is authorized to issue and have outstanding at any one time is and shall be the maximum number authorized by the Rules of Subchapter S of the Internal Revenue Code. Pursuant to law at the time of incorporation the maximum number of shares authorized by the Rules of Subchapter S is thirty-five (35) shares of one class of stock. Therefore, the maximum number of shares which the Professional Services Corporation to be known as Jim Adams Interiors INC. is currently authorized to issue is thirty-five (35) shares of common stock.

ARTICLE V. INITIAL REGISTERED AGENT AND STREET ADDRESS

The Initial Registered Agent and the street address of the Initial Registered Office in the State of Florida of the Professional Service Corporation to be known as Jim Adams Interiors INC. shall be:

The President from time to time may change the Registered Agent and/or move the Registered Office of the Professional Service Corporation to be known as Jim Adams Interiors INC. to any other address in the State of Florida.

ARTICLE VI. INCORPORATOR

The name and street address of the person signing these Articles of Incorporation as the Incorporator of the Professional Service Corporation to be known as Jim Adams Interiors INC.. is:

ARTICLE VII. TERM OF EXISTENCE

The Professional Service Corporation to be known as Jim Adams Interiors INC. shall have perpetual existence, commencing upon filing of these articles.

ARTICLE VIII. MANAGEMENT OF THE CORPORATION

This Professional Service Corporation to be known as Jim Adams Interiors INC. shall be managed by the President. The President shall be the majority shareholder except that when no one person is a majority shareholder the Professional Service Corporation shall be managed by an elected President. The President shall assume office after election by the shareholders on the basis of one vote for each share of stock owned. In the event that no shareholder receives a majority of the votes cast, the shareholder having the longest period of employment by the Professional Services Corporation shall be appointed as President and shall hold office until the next election. Elections shall be held during the annual meeting of shareholders and at such other time as designated in the By-Laws of the Professional Services Corporation.

ARTICLE IX. INITIAL PRESIDENT

The name of the Initial President of the Professional Services Corporation to be known as Jim Adams Interiors INC. and the President's street address is:

The person named as Initial President shall hold office for the first year of existence of the Professional Service Corporation to be known as Jim Adams Interiors INC. or until the President's successor is elected or appointed and has become qualified to accept the position,

ARTICLE X. AMENDMENT

These Articles of Incorporation of the Professional Service Corporation to be known as Jim Adams Interiors INC. may be amended in the manner provided by law. Every amendment shall be approved by the President, proposed by the President to the stockholders and approved at a stockholders' meeting by at least a majority of the stockholders entitled to vote, unless all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.
