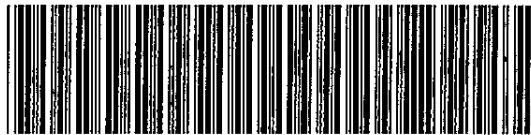

ARTICLES OF INCORPORATION  
OF  
DAVE SCHLEGEL, INC.

ARTICLE I - NAME

The name of this corporation shall be DAVE SCHLEGEL, INC., and the address of the principal office of the corporation is 32336 Hermitage Drive, DeLand, Florida 32720.

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

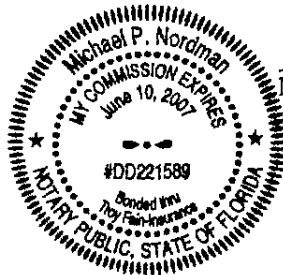
