

**ARTICLES OF INCORPORATION
OF**

MIKE OVERCASHER ENTERPRISES, INC.

The undersigned incorporator of these Articles of Incorporation does hereby form a corporation pursuant to the Florida General Corporations Act and does hereby adopt the following Articles of Incorporation:

**ARTICLE ONE
NAME AND PRINCIPAL OFFICE**

The name of this corporation is Mike Overcashier Enterprises, Inc. The corporation's principal office is located at 1803 Springwood Circle South, Clearwater, FL 33763.

**ARTICLE TWO
DURATION**

The corporation is to exist perpetually.

**ARTICLE THREE
PURPOSE**



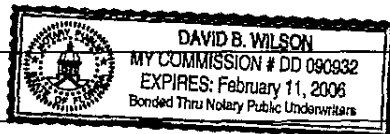


ARTICLE SIX
