The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: Mathis Flooring, Inc. The principal office of the Corporation is 2002 Crescent Boulevard, Orlando, Florida 32817. The mailing address of the Corporation is 2002 Crescent Boulevard, Orlando, Florida 32817.
  - Article 2. Duration. The duration of the Corporation is perpetual.
- Article 3, Purpose. The general purposes for which the Corporation is organized are the following:
- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.
