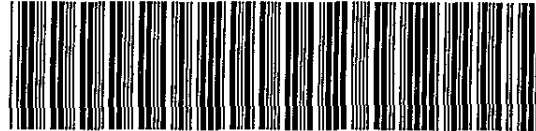

OF

THE UNDERSIGNED INCORPORATOR, MICHAEL M. GREEN, HEREBY FORMS MIKE GREEN SALES, INC., A CORPORATION UNDER CHAPTER 607 OF THE LAWS OF THE STATE OF FLORIDA.

ARTICLE I. NAME
