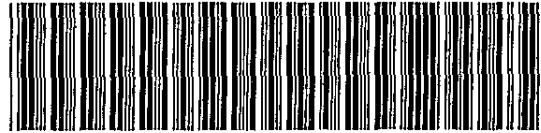

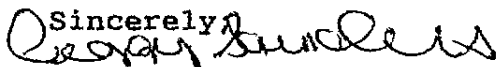

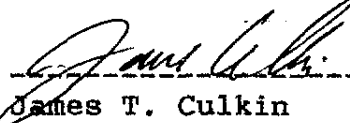
ARTICLE VIII
