ARTICLES OF INCORPORATION
OF
ANALYSIS, DESIGN & INTERACTIVE CUSTOM TRAINING, INC.

The undersigned, desiring to form a for profit corporation under the Corporation Law of Florida, Chapter 607 of the Florida Statutes, hereby certifies:

ARTICLE I – NAME

The name of the Corporation shall be ANALYSIS, DESIGN & INTERACTIVE CUSTOM TRAINING, INC.

ARTICLE II – PRINCIPAL OFFICE

The place in Florida where the principal office of the Corporation is to be located is the City of Palm Beach Gardens, Palm Beach County.

ARTICLE III – PURPOSE
