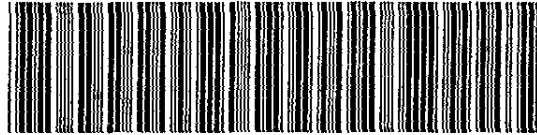

ARTICLE I - NAME

The name of the Corporation shall be **VIRO MANUFACTURING COMPANY, INC.**
