

**ARTICLES OF INCORPORATION
OF**

TERRI WATSON TRUCKING, INC.

The undersigned subscribers to these Articles of Incorporation, a natural person to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is: TERRI WATSON TRUCKING, INC..

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in any activity of business permitted under the laws of The United States and of the State of Florida.

ARTICLE III. TERM OF EXISTENCE

The period or duration of this Corporation shall have perpetual existence.

ARTICLE IV. POWER

This corporation is authorized and empowered to do all things necessary to carry on and accomplish the purposes for which it is organized and chartered, subject only to limitations imposed by the Articles of the Constitution and Bylaws of TERRI WATSON TRUCKING, INC., including all authority and power granted by Florida Law.

ARTICLE V. PURPOSE

This Corporation is organized and shall be operated exclusively for the purpose of transacting any or all lawful business.

ARTICLE VI. CAPITAL STOCK

Section 1: The aggregate number of shares which this Corporation shall have authority to issue is 1000 common share, having a par value of \$1.00 per share. The stock of this Coporation shall be divided initially as follows:

Section 2: All certificates of stock shall be signed by the President and Secretary and shall be sealed with the corporate seal. Certificates of stock shall be in the form adopted by the stockholders at their first meeting and as attached to the Minutes of the first meeting of the stockholders and identified as the form of the stock certificates for this corporation. All certificates shall be consecutively numbered.

Section 3: In case of loss or destruction of certificate of stock, no new certificate shall be

issued in lieu thereof except upon satisfactory proof, to the officers required to sign the same, of such loss or destruction; and upon giving satisfactory security, by bond or otherwise, against loss to the corporation any such new certificates shall be plainly marked "duplicate" upon its face.

ARTICLE VII. PREEMPTIVE RIGHTS

Every shareholder, upon the sale of cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VIII. INITIAL REGISTERED OFFICE AND AGENT

The address of the initial registered of this Corporation is: 733 SW 242-A, Lake City, Florida, 32025; and the name of the initial registered agent of this Corporation at that address is: TERRI L. WATSON.

ARTICLE IX. PRINCIPAL PLACE OF BUSINESS

The address of the principal place of business of this Corporation is: 733 SW 242-A, Lake City, Florida, 32025.

ARTICLE X. INITIAL OFFICERS

The affairs of this Corporation shall be managed by a President, Vice President, Secretary, and Treasurer and such other officers as permitted in the Bylaws. The names and addresses of those persons who shall act as officers of this Corporation until the assignment of their successors are as follows:

ARTICLE XI. INITIAL BOARD OF DIRECTORS

This Corporation shall have two directors initially. The number of directors may be either increased or diminished from time to time by the By-Laws, but shall never be less than one. The name and address of the initial directors of this Corporation are:

The business of this corporation shall be managed by its stockholders rather than by a Board of Directors. In the management of the business of the corporation, the act of the stockholders representing a majority of the outstanding shares of the corporation entitled to vote, whether represented in person or proxy, shall be the act of the stockholders. Each stockholder shall be

entitled to one vote in person, or by proxy, for each share of voting stock held by him or her. A majority of the outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall constitute a quorum at any meeting of the stockholders for the management of the business of the corporation.
