ARTICLE I. CORPORATE NAME

ARTICLE II NATURE OF BUSINESS AND POWERS

ARTICLE VIII AMENDMENT



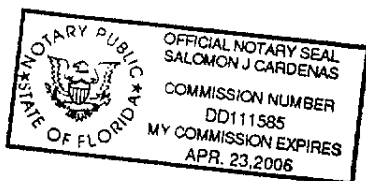


