The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

Name, Location and Mailing Address of Principal Office

The name of the corporation is KRISHNA MART, INC. The principal office is located at 614 Pecan Park Road, #C-65,76, Jacksonville, Florida 32218, and the mailing address of this corporation is P. O. Box 18823, Jacksonville, Florida 32229.

ARTICLE II Purpose

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States and the State of Florida.

ARTICLE III Capital Stock

This corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 35 persons. Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in Section 1361(c)(2)(or its successor section) of the Internal Revenue Code. In addition, no stock shall be issued or transferred to a nonresident alien. The corporation is authorized to issue five hundred (500) shares of capital stock, of which 500 shares shall be issued to Pankaj Kumar Garg, each share having a par value of \$1.00.

ARTICLE IV Initial Registered Office and Agent
