
I have talked to you in the past about getting a corporation reinstated. You told me that the Secretary of State would consider reinstatement without the penalty if the forms were never received.

I am the accountant for Dana's Daycare, Inc., [corporation] a corporation organized under the laws of the State of Florida. I noted when I checked the Division of Corporation's website that the annual fees had not been paid by the corporation for 2005. Mrs. Dana L. Bromm was not aware that the corporation was being administratively dissolved until I brought it to his attention.

When I questioned Mrs. Bromm about his receiving the UBR that the State of Florida mailed to him in early January 2005, she stated she never received the form. Since Mrs. Bromm never received the UBR for 2005, we are requesting an abatement of the late filing fees and asking that the corporation be reinstated for the payment of the 2005 fee only in the amount of \$150.

The corporation has enclosed its check in the amount of \$150.00 made payable to the Department of State to reinstate the corporation and pay the annual fees for 2005 ---- which is due by May 1, 2005. Thank again for your assistance.
