

OF
BAYLON CARPENTRY, INC.**

ARTICLE I - NAME

The name of this corporation BAYLON CARPENTRY, INC.

ARTICLE II - PURPOSE

This corporation is organized for the following purposes:

1. To operate a business related to Residential/New Home Construction;
2. To transact any and all lawful business.

ARTICLE III - POWERS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

ARTICLE IV - CAPITAL STOCK

- A. This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which shall be designated "common shares."
