ARTICLES OF INCORPORATION

OF

SPENCE'S TAPING INC.

SECRETARY OF STATE TALLAHASSILE. FLORIDA

ARTICLE I - NAME

The name of the corporation is Spence's Taping Inc., at 1360 Ashford Avenue NE, Palm Bay, FL 32907 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

ARTICLE IV - CAPITAL STOCK
