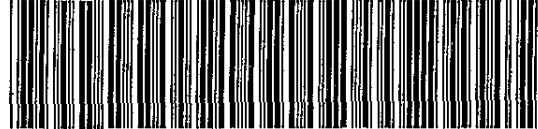

**ARTICLES OF INCORPORATION
OF
LA NOPALERA MEXICAN RESTAURANT #6, INC.**

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida in Compliance with Chapter 607 and/or Chapter 621, F.S. (Profit).

ARTICLE 1 – NAME

The name of the corporation shall be:

ARTICLE II – INITIAL PRINCIPAL OFFICE

ARTICLE III – DURATION

This corporation is to commence its corporate existence on the date of filing by the Secretary of the State of Florida. This corporation shall exist perpetually.

ARTICLE IV – PURPOSE

This corporation is organized for the following Purposes:

The transaction of any and all lawful business for which corporations may be incorporated, including but not limited to those powers enumerated in Florida Statutes Section 607.0302, et. seq., as amended, and the doing of all lawful things related thereto.

ARTICLE V – CAPITAL STOCK

The shares of stock may be issued for such consideration, having a value not less than the par value of the shares issued therefore, as is determined from time to time by the board of directors, to be paid, in whole or in part, in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation.

The corporation shall indemnify and present or former officer, incorporator, or director, or person exercising powers and duties of a director, to the full extent now or hereafter permitted by law.


ARTICLE XI – BYLAWS


