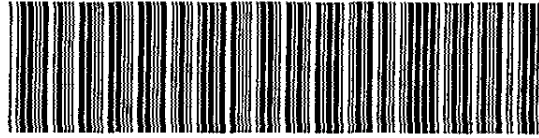

do hereby form a corporation under the laws of the State
of Florida.

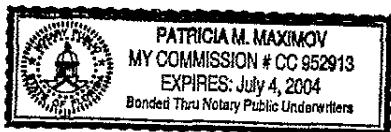


