ARTICLES OF INCORPORATION OF K & J CARPET INSTALLATIONS INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I-NAME

The name of the company is: K & J CARPET INSTALLATIONS INC.

ARTICLE II - PRINCIPAL OFFICE
