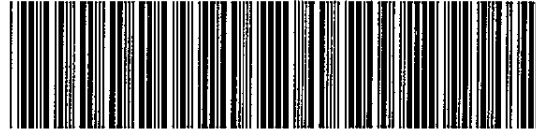

The undersigned, for the purpose of forming a subchapter corporation for profit under the laws of the State of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I

Name, Location and
Mailing Address of Principal Office

The name of the corporation is **Kreyol Synergy, Inc.** The principal office and mailing address of this corporation is 12100 Spindlewood Court, Jacksonville, FL 32246.

ARTICLE II

Purpose

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States and the State of Florida.

ARTICLE III

Capital Stock

This corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than **35 persons**. Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in Section 1361(c)(2) (or its successor section) of the Internal Revenue Code. The corporation is authorized to issue 400 shares of capital stock, of which 100 (one hundred) shares shall be held by each one of the four directors, each share having a par value of \$200.00.

ARTICLE IV

Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 12100 Spindlewood Court, Jacksonville, FL 32246 and the name of the initial registered agent of the corporation at that address is **Jacques Guillaume**.

ARTICLE V

Directors

This corporation shall initially have two directors. The number of directors may be increased or decreased from time to time but shall never be fewer than one nor more than five. The name, street address and title of the members(s) of the first Board of Directors of the corporation are:

The Board of Directors is hereby specifically authorized to make provision for reasonable compensation to its members for their services as directors, and to fix the basis and conditions upon which such compensation shall be paid. Any directors of the corporation may also serve the corporation in any other capacity and receive compensation in any form.

ARTICLE X
Indemnification

The Board of Directors is hereby specifically authorized to make provision for indemnification of directors, officers, employees and agents to the full extent permitted by law.
