ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE I

This directors shall hold office until the first annual meeting or until his successor is elected or appointed and qualified as provided in the By-Laws.




