ARTICLES OF INCORPORATION OF

The undersigned incorporators, for the purposes of forming a corporation under the Florida Business Corporation Act, herby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of this Corporation is: Chris Casella Construction, Inc.

ARTICLE II TYPE OF CORPORATION

Chris Casella Construction, Inc. will conduct business as a "S Corporation", wherein the corporation will file federal taxes with the Internal Revenue Service on Form 1120S, after filing Form 2553 electing to be a S Corporation with the IRS.

ARTICLE III ADDRESS OF THE PRINCIPLE OFFICE
