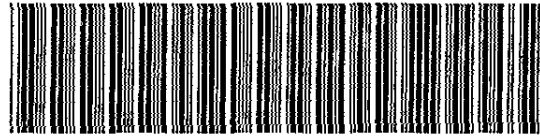

**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporators of the corporation in compliance with the Florida Business Corporation Act, adopt the following articles of incorporation for said corporation.

**ARTICLE I**

The name of the corporation shall be The Final Frontier Homes, Inc.

**ARTICLE II**

The principal place of business and mailing address of this corporation shall be 1945 Fern Palm Drive, Edgewater, Florida 32141.

**ARTICLE III**

The purpose is to engage in any activities of business permitted under the laws of the United States of America and the State of Florida.




