ARTICLES OF INCORPORATION OF BARRY STINSON, INC.

(I)

The Name of the Corporation is Barry Stinson, Inc.

(II)

The Corporation is organized pursuant to the provisions of the Florida Business Corporations Act.

(III)

The period of its duration is perpetual.

(IV)

The Corporation is a corporation for profit and is organized for the following purposes:
